Use of Middle Grades Integrated Curriculum for Meeting Highly Qualified Status in Department of Juvenile Justice Educational Programs 2006-2007 School Year

Purpose

The purpose of this technical assistance paper is to provide information about meeting highly qualified status under the middle grades integrated curriculum for juvenile justice education teachers. Even though this document provides information for DJJ teachers, the requirements apply to all teachers.

Background

Title I, Part A, of No Child Left Behind (NCLB) requires all teachers in core academic areas (English, reading or language arts, mathematics, science, history, civics and government, geography, economics, the arts, and foreign languages) to be highly qualified. To be considered a highly qualified teacher, a teacher must have the following:

- Bachelor's degree
- Full state certification or licensure
- Demonstrated competency in each subject taught

Recruiting and retaining highly qualified teachers in juvenile justice education programs has become a significant challenge. There are many teachers in small juvenile justice programs who teach multiple grades and subjects. In order to meet highly qualified status, teachers must demonstrate competencies in core subjects through subject area testing.

Highly Qualified Status under Middle Grades Integrated Curriculum

The middle grades integrated curriculum certification offers teachers who teach multiple subject areas a means of meeting highly qualified status. Currently there are 57 middle school courses and 61 high school courses where middle grades integrated curriculum certification is appropriate for the 2006-07 school year. (See attached table.) Please note that reading courses require teachers to have certification or endorsement in reading.

A certified teacher can obtain highly qualified status for the middle grades integrated curriculum by achievement of a passing score on the middle grades integrated curriculum examination and applying to have the subject area added to their teaching certificate.

Remedial = Remedial and compensatory courses taken in grades 9-12 may only be counted as elective credit toward high school graduation.

Level 1= No student may be granted credit toward high school graduation for enrollment in any Level 1 course unless the student's assessment indicates that a more rigorous course of study would be inappropriate, in which case a written assessment of the need must be included in the student's individual educational plan or in a student performance plan, signed by the principal, the guidance counselor, and the parent or guardian of the student, or the student if the student is 18 years of age or older. See section 1003.43(7)(d), F.S. If these requirements are met, a Level 1 course may meet subject area graduation requirements.
